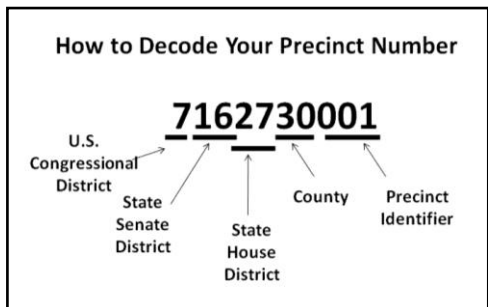

Most of us in Candlelight Valley Homeowners Association are in Precinct 7162730001. Only the 10 homes along the east side of Fig Way and Fig Court are in Precinct 7202730005. The only difference in our elected officials is State Senator. So we list both senators in the table.

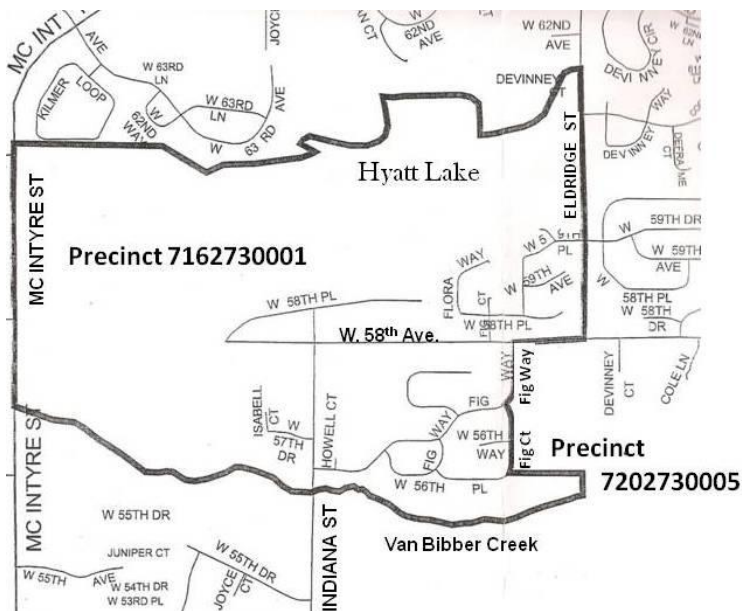
I know we printed the precinct map and how to decode your precinct number in the last two newsletters along with the candidate information, but here they are again so you'll have them with this table.

*In Candlelight Valley, just the ten homes on the east side of Fig Way or east side of Fig Court.*

2 year term.

6 year terms. Nine members: We vote for 2 at large and for the 1 representing our Congressional District.

**District 7** Monisha Merchant (D) Term expires 1/2015

### Colorado State Board of Education

6 year terms. Seven members, 1 per Congressional District. We vote for our District's member.

4 year staggered terms. Elected at large (i.e. we vote for all).  
However we are in District 1.
